### *Objective:*

Readings and discussions in a small group of recent research papers representing the state-of-the-art of research in the ecological psychology tradition of situated learning. Review of theories, models for analyses and applications in various work practice settings. Critical examination of research papers with respect to design, instrumentation and data collection, choice of subjects, internal and external validity.

### *Topic areas:*

Decontextualized vs contextualized learning; Behavior setting analyses ; Psychology of planned action; Scientific work as practice; Human activity systems theory; Socially situated activity; Skills development in social interactions, Interdependence of knowledge and action; Craftwork; The study of expertise, new-comers and novices; Role of pre-experience and cognition in situated learning.
